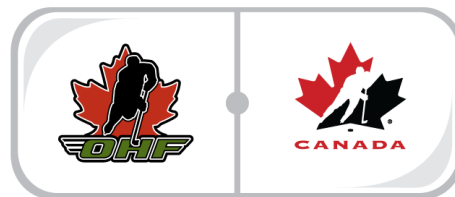

The Ontario Hockey Federation wants to understand your experiences with the new Playing Regulations for the 2023-2024 season. Three (3) surveys will be sent over the 2023-2024 hockey season.

The first survey that was sent out in September sought feedback on the Preparation and Evaluation Phases. This second survey explores your experience with the **Development Phase**. The survey will take approximately 5 minutes to complete. As a reminder:



- The **Development Phase** is a 27-day period that takes place after Labour Day where teams may only play a minimum of four (4) exhibition games and/or one Tournament. On-ice practices are permitted during this period.

Your feedback will be used in future decisions that support player development.

Your participation is completely voluntary. You do not have to answer any questions you do not want to and may stop the questionnaire at any time.
